AFC Crews battle wildfires across Southern Arkansas

LITTLE ROCK, ARK. – Arkansas Forestry Commission personnel responded to a wildfire on Timberlake Road west of Hot Springs, and are on the scene of another near the community of Traskwood in Saline County, as well as a fire near Cooper Church in Hot Spring County. Current acreage estimates are not available at this time, and no reports have been received of homes threatened.

Crews have also been contained a five to seven-acre fire, and two dozer crews are working a four to five-acre fire in Lincoln County. Bradley County personnel extinguished a ¼-acre fire. No homes are threatened at this time. The AFC has begun detection flights in districts 1, 4, 5 and 9. Pulaski and Perry County AFC personnel have contained an estimated 25-acre fire on Deltic Timber property in Western Pulaski County. Two fires have been contained in Nevada County.

According to the Arkansas Forestry Commission Dispatch Center in Malvern, 21 counties are currently under burn bans: Ashley, Chicot, Clark, Cleveland, Columbia, Crawford, Dallas, Faulkner, Garland, Hempstead, Jefferson, Johnson, Lafayette, Lincoln, Miller, Nevada, Ouachita, Polk, Pulaski, Saline and Sebastian.

Due to the high heat index values and fire danger risk, the Arkansas Forestry Commission is urging all Arkansans to avoid burning. Battling wildfires in extreme temperatures can put the health of firefighters and other emergency responders at risk.

On Sunday, AFC crews responded to 13 wildfires that burned approximately 693 acres in eight counties. This includes a wildfire in Lafayette County that charred nearly 400 acres approximately eight miles northeast of the community of Bradley. A Forestry Commission firefighter was taken to a nearby hospital for treatment for smoke inhalation and heat exhaustion. He was treated and released.

AFC personnel were dispatched to two fires in Lafayette County, four fires in Hot Spring County, two in Bradley County, and one fire each in Sevier, Miller, Ouachita, Dallas and Scott Counties.

With little significant rainfall in sight, Arkansas residents living in forested areas should begin taking measures to protect their homes from wildfire. Even the smallest steps taken can lead to a huge advantage in ensuring your home will remain standing.

With a high fire danger risk, there are a few things to remember:

- Burning is strongly discouraged. This is especially true on days where humidity levels have dropped below 30 percent and winds are gusty. Fires can spread quickly in these conditions.
- Be mindful that sparks from lawn mowers and hay baling equipment can start a wildfire.
- Never discard cigarettes from vehicles.
- Never park vehicles where grass or other vegetation can touch the exhaust system.

Arkansas FireWise Coordinator David Samuel recommends homeowners create a minimum 30-foot “defensible space” around their house. Defensible space is an area around a structure that provides an opportunity to modify the existing vegetation to slow the rate and intensity of an advancing wildfire.

Homeowners should thin flammable trees, such as pine, near their home and remove undergrowth that can serve as a link for grass fire to reach treetops. Also, be sure to remove dead leaves and pine needles from roofs, gutters and along the base of your home.

Other suggestions include:

- Keep trees and shrubs pruned. Prune all trees from six to 10 feet above the ground.
- Remove overhanging branches from your roof.
- Mow your yard regularly.
- Store firewood away from the house.
- Dispose of cutting and debris promptly, according to local regulations.
- Homeowners should use 1/8-inch screen to cover open areas underneath decks. This prevents embers from igniting vegetation beneath the deck, which can in turn ignite the structure.
